Bidding Overview: There are three ways to bid on vehicles offered for sale at Copart auctions:

Once a Preliminary Bid has been placed, it may not be changed or deleted.

"Preliminary Bid" - Buyers may log on to Copart's website at www.copart.com, or onto a VB2 kiosk at a Copart auction facility and submit bids electronically in advance of the scheduled virtual auction date. The highest Preliminary Bid received by Copart will compete against Virtual Bids (see below) at the VB2 virtual auction.

"Virtual Bid" - Buyers may log on to Copart's website at www.copart.com during a VB2 virtual auction to submit bids electronically, in real time over the internet, to compete with Preliminary Bids, and other Virtual Bids.

I. DISCLAIMERS

A. Vehicle Condition and History Disclaimer.

ALL VEHICLES ARE SOLD "AS-IS WHERE-IS"

All vehicles sold through Copart auctions are sold "AS-IS WHERE-IS", WITHOUT ANY WARRANTY, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE OR MERCHANTABILITY. Copart and its vehicle suppliers expressly disclaim the accuracy or completeness of any and all information provided to Buyers regarding vehicles, whether provided in written, verbal, or digital image form ("Vehicle Information"). Vehicle Information provided by Copart and its vehicle suppliers is for convenience only. Buyers shall not rely on Vehicle Information in deciding whether or how much to bid on a vehicle offered for sale at a Copart auction. Vehicle Information includes but is not limited to: year, make, model, condition, ACV, damage amount, damage type, drivability, accessories, mileage, odometer disclosures, vehicle identification number ("VIN"), title, repair history, title history, and total loss history. Copart and its vehicle suppliers expressly disclaim any and all representations, warranties, and guarantees regarding vehicles sold at Copart auctions. III. MEMBERSHIP

A. Membership Eligibility. Membership as a registered Buyer at Copart Auto Auctions is open to individuals 18 years of age and older. In addition, yard-specific registration requirements and applicable federal, state, provincial and local laws, regulations and restrictions may further limit Buyer membership eligibility and out-of-state provincial vehicle purchasing ability. Copart reserves the right to deny membership privileges to, or exclude from Copart facilities, any individual or entity, in its sole and absolute discretion.

B. Registration. Registered Buyers must complete the buyer registration form, and pay a one-time nonrefundable registration fee of \$200(\$___ Canadian). Wholesale purchasers must provide copies of current licenses and completed sales tax exemption certificates. Membership must be renewed annually by paying the \$100(\$___ Canadian) annual membership renewal fee and submitting copies of all current licenses, and any information regarding change of ownership or address. Copart reserves the right to increase registration and renewal fees at any time without notice.

C. I.D. Cards. Upon registration, Copart will issue identification cards in accordance with the guidelines in effect in the area of Buyer's registration. I. Release of Liability and Indemnification. Buyers and their guests irrevocably and unconditionally waive and release their rights (if any) to recover from Copart, its directors, officers, employees, representatives, agents, subsidiaries, partners, and affiliates any and all damages, losses, liabilities, costs, expenses, or claims whether direct or indirect, known or unknown, or foreseen or unforeseen, which may arise from or be related to bodily injury, property damage, or other occurrence which occurs on Copart premises. Buyers agree to indemnify, defend, and hold Copart harmless from any and all damages, losses, liabilities, costs or expenses, arising from claims made by Buyer guests for bodily injury or property damage occurring on Copart premises. UNDER NO CIRCUMSTANCES, INCLUDING NEGLIGENCE, WILL COPART BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OR LOST PROFITS THAT RESULT FROM OR ARE RELATED TO THE SALE, DISTRIBUTION, USE OF, OR INABILITY TO USE, ANY VEHICLE, EVEN IF COPART HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Buyers and guests who are California residents waive California Civil Code §1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

IV. FEES, PAYMENT AND DELIVERIES

A. Fees. All Buyer, storage, and delivery fees applicable at each Copart facility vary by location and are subject to change without notice. A fee will be charged for each duplicate Salvage Certificate or Bill of Sale at all facilities. Buyer is solely responsible for ascertaining fees applicable to a Copart facility prior to incurring any charges.

B. Payment. Payment for vehicles may be made by either cashier's check or money order. Acceptance of company checks is subject to prior approval by the Copart Accounting Department. Buyers agree to be personally liable for payment of any cashier's check, money order or check that is dishonored. In the event of a dishonored cashier's check, money order, or check, Buyer agrees to make payment within two days after receipt of notice from Copart of a dishonored check, and to pay Copart's NSF processing fee, and any and all collection costs including but not limited to, collection agency fees, and/or attorney's fees and court costs.

C. Sales Tax Indemnification. Buyers purchasing vehicles from Copart at wholesale pursuant to a sales tax exemption certificate agree to indemnify, defend, and hold Copart harmless from any and all sales tax assessments, fines, penalties, damages, and costs, including attorneys fees, incurred as a result of a determination by taxing authorities that the transaction was subject to the payment of sales or excise tax.

D. Relist Fees.
